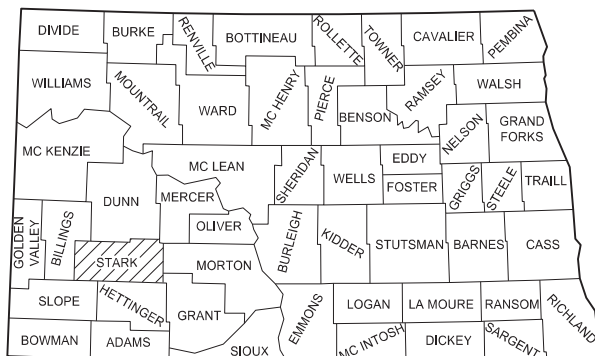
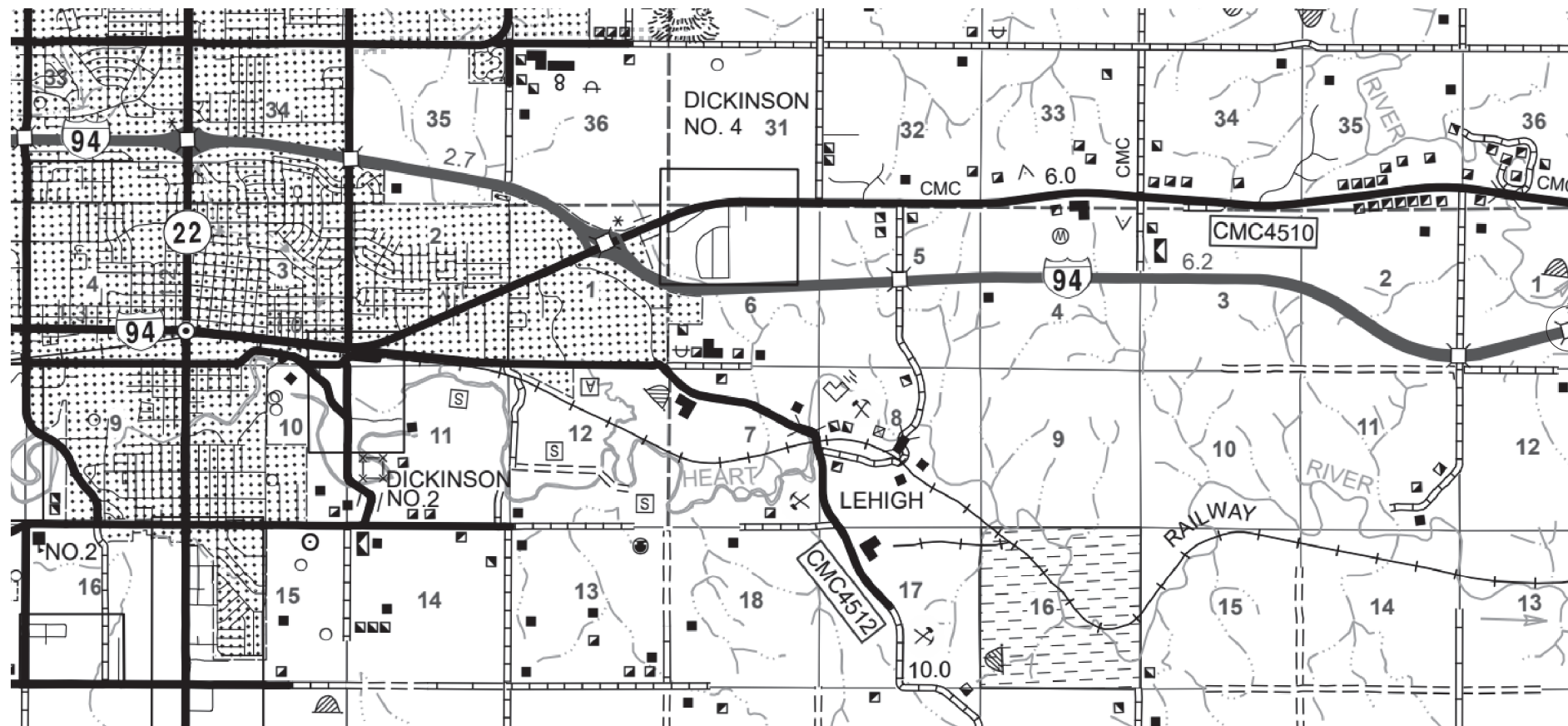

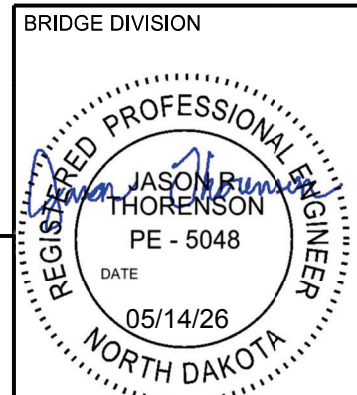

704-200 STATE FURNISHED MEDIAN BARRIER: Obtain (61) 2.5' x 10' concrete barriers. They can be picked up and returned to the Williston District yard at US 2 RP 12. Contact the Williston District office at 701-774-2700 to facilitate the exchanges.

If returning barriers with connection components, coordinate the delivery location for the connecting components with the Engineer. Some 4 inch x 4 inch boards are available at the return location. Provide any additional 4 inch x 4 inch boards necessary to stack barriers. The boards will become property of the Department.

Include all costs associated with median barriers in the contract unit price for "State Furnished Median Barrier".

704-P01 TRAFFIC CONTROL DEVICES: The traffic control devices list has been developed using the following layout in the Standard Drawings for traffic control.

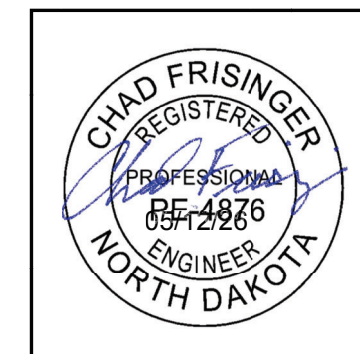

Devices are provided for the Left Lane Closure on the I-94 Eastbound Roadway at Bridge 094-070.364 R – Green River.

For the left lane closure, install signing, devices, and pavement markings as shown on Standard Drawing D-704-18.

704-P02 MODIFY ATTENUATION DEVICE FOR TWO-WAY TRAFFIC: There is an existing Attenuation Device – Type B-80 located near the west bridge end of the Eastbound Green River Bridge, RP 70.364. Relocate the existing barrel Attenuation Device – Type B-80 to the end of the state furnished median barriers, as shown in Section 100.

Include all costs to relocate the existing attenuation device, including all materials, equipment, and labor, in the contract unit price bid for "Modify Barrel Attenuation Device."

764-P01 REMOVE W-BEAM GUARDRAIL MATERIALS & POSTS: At the Eastbound Green River Bridge, RP 70.364, there is a total of 150 lineal feet that is in normal state including the entire 50-foot end terminal and 100 feet attached to the end terminal. This guardrail is to remain in place.

The remaining length has 30 guardrail posts broken or completely sheared off at the ground line with the portion of the above ground components mostly removed from the site. At the end of removal near the end terminal there is approximately 25 lineal feet of existing rail that is damaged and hanging. At the bridge end there is approximately 12.5 lineal feet of damaged guardrail, posts, blocks, rub rail, and associated hardware in place. The existing bridge rail transition is as shown in D-764-11.

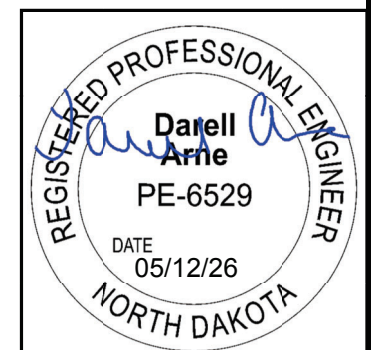
Plan quantity will be used as the measurement for the payment of the removal length.

Deliver any removed guardrail materials identified by the Engineer as usable to the NDDOT Maintenance Storage Yard in Dickinson and neatly stack them at a location designated by the Engineer. The address of the NDDOT Maintenance Storage Yard is:

- 100 SCOPE OF WORK: Work at this site consists of removing and replacing the damaged concrete safety shape barrier on the approach slab, repairing concrete spall areas on the bridge jersey barrier, and repairing damaged deck drain.
- 930 MODIFY DECK DRAIN: Repair the damaged deck drain by cutting the existing PVC deck drain flush with underside of the deck and installing new drain components beneath the bridge deck. Field measure the existing deck drain before ordering materials.
- 930 SPALL REPAIR: The barrier has areas of damaged concrete as shown. See supplemental bid information for photos of concrete damage. The extent of repairs as shown in the plans are approximations. The actual limits and number of repair locations are to be determined by the Engineer in the field.



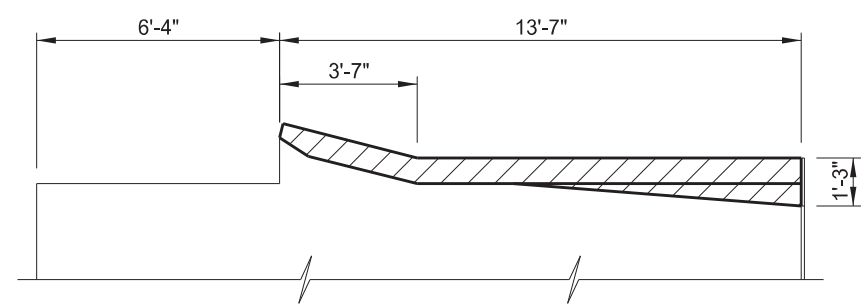

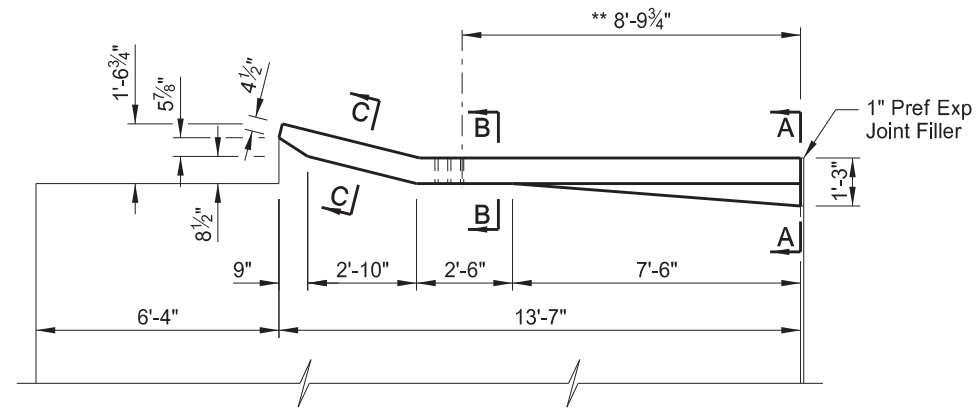

SAFETY SHAPE BARRIER PLAN

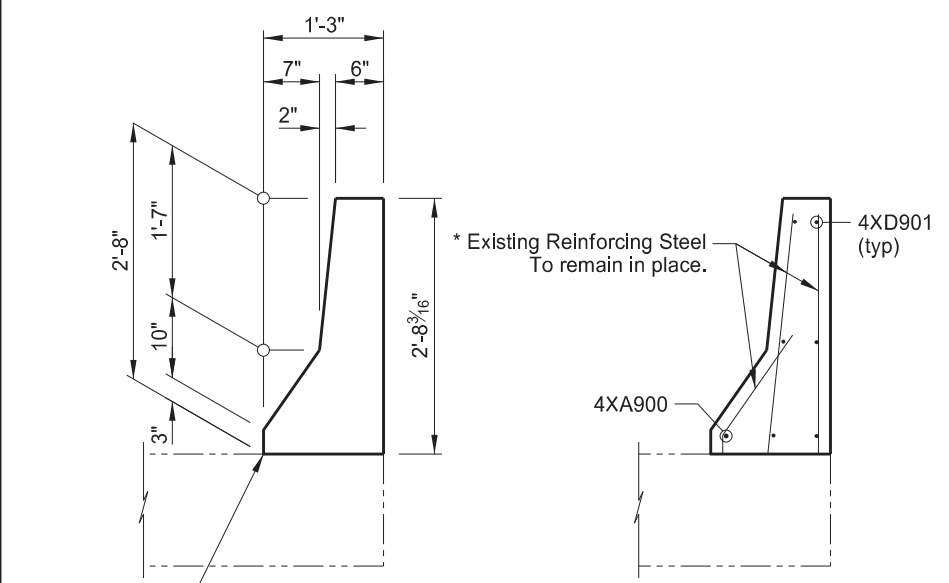

Replace damaged reinforcing steel according to manufacturer's recommendations with a high strength adhesive specifically intended for concrete anchorage (16k min. ultimate pullout) and that meets the requirements of Section 806.02. Provide a minimum anchorage length of 1 foot. Refer to Sections A-A, B-B and C-C for location of bars to be drilled and anchored into existing approach slab concrete.

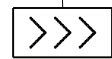

Place signs over 50 square feet on 2 1/2" x 2 1/2" perforated tube supports as a minimum.

Do not attach guy wires to sign supports. Attach wind beams behind sign panels when used with u-posts.
- Sign Panels: Provide sign panels made of 0.100" aluminum, 1/2" plywood, or other approved material, except where noted. Punch all holes round for 3/8" bolts.
- Alternate Messages: Install and remove alternate message signs on reflectorized plate (without borders) as required. (i.e. "Left" and "Right" message on lane closure sign)
- Route Marker Auxiliary Signs: Provide route marker auxiliary signs, such as the cardinal direction and directional arrows, with a background and legend that match the route marker they are used with:

Interstate - white legend on blue background
Interstate Business Loop - white legend on green background
US and State - black legend on white background
County - yellow legend on blue background

- Vertical Clearance: Install signs with a vertical clearance of 5'-0" (see TYPICAL SECTION.) In areas where parking or pedestrian movements are likely or the view of the sign may be obstructed, install signs with a vertical clearance of 7'-0" from the top of the curb or from the near edge of the driving lane in absence of a curb.

The vertical clearance to secondary signs is 1'-0" less than the vertical clearance stated above.

Provide a minimum clearance of 7'-0" from the ground at the post for signs with an area exceeding 50 square feet.
- Portable Signs: Provide portable signs that meet the vertical clearance stated above when it is necessary to place signs within the pavement surface.

Use of low-mounting height (minimum 12" vertical clearance) portable signs for 5 days or less, is allowed as long as the view of the sign is not obstructed. Time delays caused by unforeseen circumstances, such as equipment breakdown, rain, subgrade failures, etc., will not accrue towards the 5 day period. Use of R9-8 through R9-11a series, W1-6 through W1-8 series, M4-10, and E5-1 is allowed for longer than 5 days.

Restrict signs mounted on portable sign supports shown in the LOW-MOUNTING HEIGHT and HIGH-MOUNTING HEIGHT details to a maximum surface area of 16 square feet.

TWO-LANE TWO-WAY ROADWAY

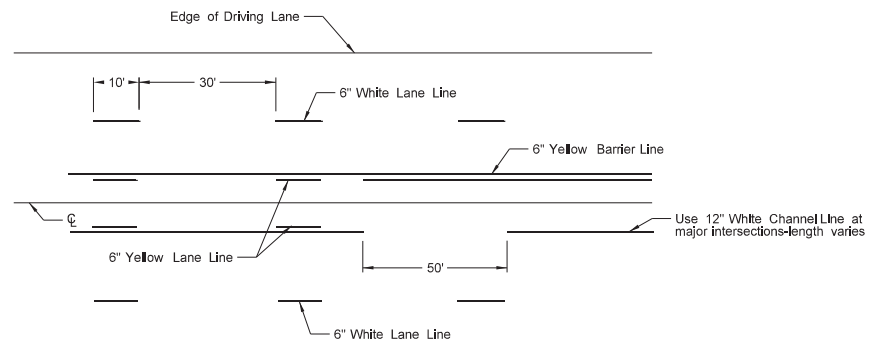

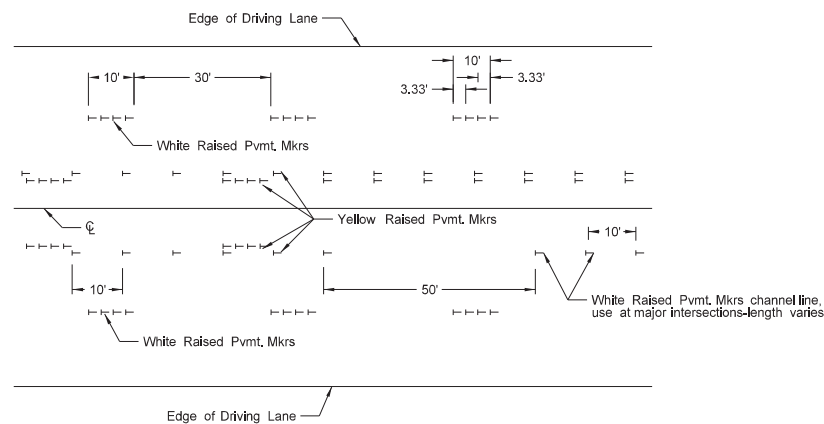

FOUR LANE ROADWAY

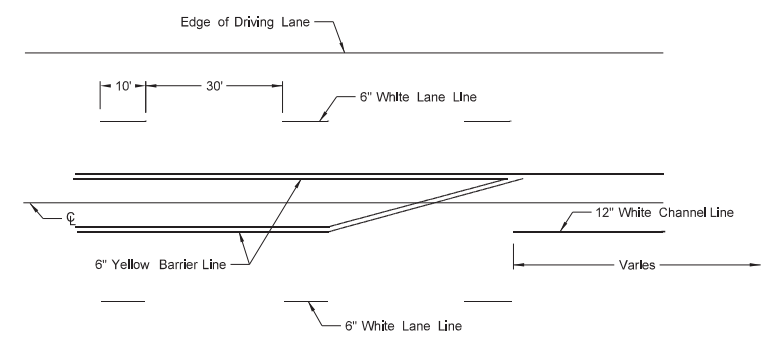

GENERAL NOTES

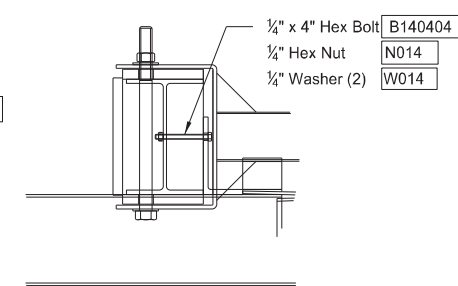
- Use wood posts with the Flared Energy Absorbing Terminal except posts #1 and #2.
- Use galvanized bolts, nuts, cable assemblies, cable anchors, and bearing plates.
- Grade site as needed to prevent lower sections of the posts from protruding more than 4 inches above the ground (measured along a 60 inch cord).
- Drive the lower section without the upper post attached. If the post is placed in a drilled hole, compact the backfill material satisfactorily to prevent settlement.
- When rock is encountered during excavation, use a 12" diameter post hole 20" into the rock surface, if approved by the Engineer. Place granular material in the bottom of hole approximately 2 1/2" deep to provide drainage. Field cut soil tubes to length, place in hole, and back fill with adequately compacted material excavated from hole.
- Place the breakaway cable assembly taut. Use a locking device (vice grips or channel lock pliers) to prevent the cable from twisting when tightening nuts.
- "Toe nail" the wood blockouts to the rectangular wood posts with two 20 penny galvanized nails in each post to prevent them from turning when the wood shrinks.
- Flare the Flared Energy Absorbing Terminal when the approach guardrail is parallel with the roadway. When the approach guardrail is flared at 16:1 to 10:1, flare the Flared Energy Absorbing Terminal at the flare rate of the guardrail. When the guardrail flare is between 10:1 and 7:1, turn the Flared Energy Absorbing Terminal parallel to the roadway.



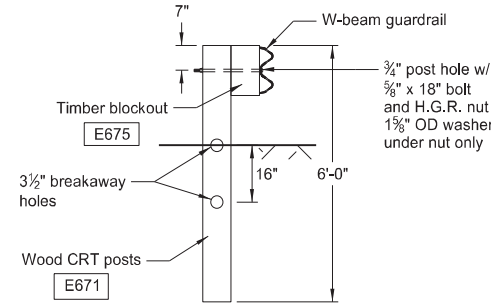

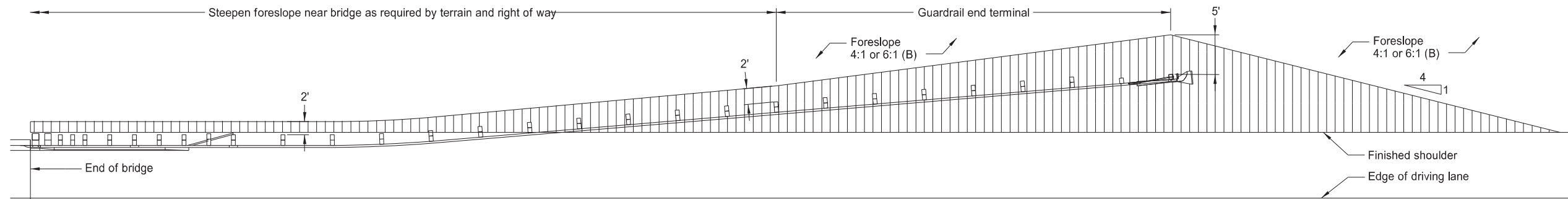

WITH W-BEAM GUARDRAIL

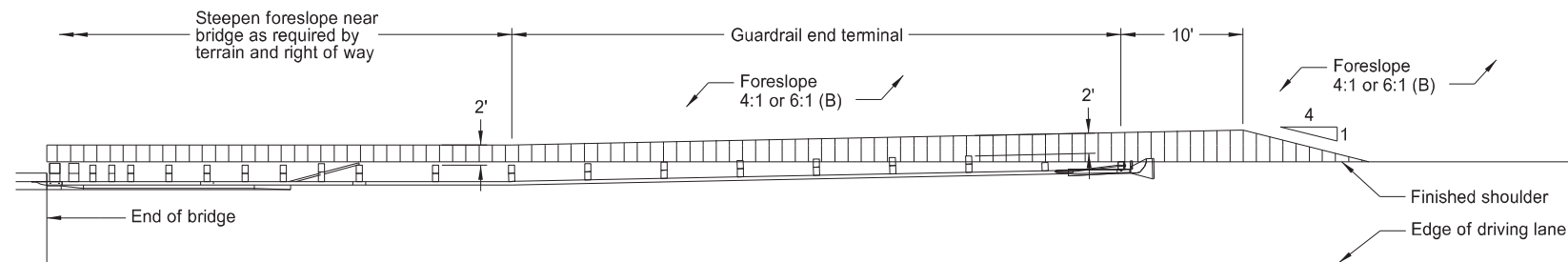

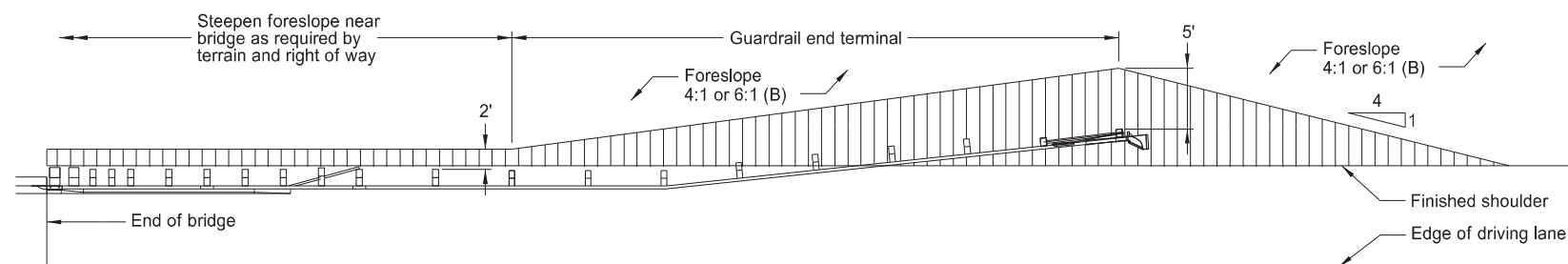
