Walsh County, Cavalier County and Pembina County will engage the services of a prequalified engineering firm to perform Construction Engineering on the following tied projects in Walsh County, Cavalier County and Pembina County scheduled to be completed in 2018.

Tied projects: HLC-5000(014), PCN 21320, HLC-1000(052), PCN 21315, HLC-3400(014), PCN 21319; NDDOT Job #12 on the April 13, 2018 Letting: The tied project consists of safety improvements at various sites located in Walsh County, Cavalier County and Pembina County, North Dakota.

HLC-5000(014), PCN 21320 is located at 11 different sites in Walsh County. Key project elements include pavement marking, curve signing and incidentals.

HLC-1000(052), PCN 21315 is located at 6 different sites in Cavalier County. Key project elements include pavement marking, curve signing and incidentals.

HLC-3400(014), PCN 21319 is located at 8 different sites in Pembina County. Key project elements include pavement marking, curve signing, destination lighting, rumble strips and incidentals.

Work to be performed by Consultant includes:

Construction Services: Perform Project Management, Project Administration and Construction. Additional services, if required, may be negotiated and supplemental agreements issued based on the consultant's performance, the consultant's proposal and available funding.

Firms are invited to submit a proposal for the project listed above. The Proposals shall provide the following information:

- Past Performance
- Ability of professional personnel
- Willingness to meet time and budget requirements
- Location
- Recent, current, and projected workloads of the persons and/or firms
- Related experience on similar projects
- Recent and current work for the County's
- Project understanding, issues, & approach

The proposal pages shall be numbered and must be limited to 10 pages in length. Proposals that exceed the 10 page length requirement will not be considered. The cover letter will not be counted as one of the 10 pages. The proposal should list the personnel who will be assigned to work on the project, including titles, education, and work experience. Walsh County,

Cavalier County and Pembina County will only consider proposals received prior to **2:00 PM, March 30, 2018**. Late proposals will be deemed unresponsive.

The consultant's proposal may include an appendix. Resumes, references, a statement of qualifications and other materials outlining experience may be included in an appendix. The appendix will not be considered as a part of the 10 page proposal. Each proposal will be evaluated by a selection committee.

Walsh County, Cavalier County and Pembina County will conduct interviews. The County's plan to interview up to three (3) of the most qualified engineering firms based on whose proposals most clearly meet the RFP requirements. Interviews will take place on a date to be determined by the County's. Firms not selected to be interviewed will be notified in writing.

Fees shall be negotiated with the successful firm. If the fee cannot be agreed upon, the County's reserve the right to terminate negotiations, and then negotiate with the second and third ranked firms in order, if necessary, until a satisfactory contract has been negotiated.

All costs associated with the proposal shall be borne by the proposer. The County's reserves the right to reject any and/or all proposals and to not award contracts for any and/or all projects.
