North Dakota Construction Storm Water Training 2014 January 21, 22, & 23, 2014 • Registration Deadline January 17, 2014.

Course Description

This is a one day course offered by the North Dakota DOT, Dept of Health and the AGC.

The course is offered in response to a growing demand to meet erosion/sediment control and storm water management permitting, compliance and training requirements on construction projects in North Dakota.

The course is designed for those who perform site management and inspection duties, supervise or direct construction operations, bid projects, oversee the installation of best management practices, and inspect sites for compliance relating to erosion/sediment control and storm water management.

This course will cover permit requirements, roles and responsibilities, and how to design and implement Storm Water Pollution Prevention Plan (SWPPP) using the EPA SWPPP Guidance Document. Other topics include review of example SWPPPs; grading practices to reduce erosion and off site sedimentation, sequencing the work and timing of installations.

Also covered will be NPDES/NDPDES site inspections, and filling out the required documentation.
