Terms of the sale will be cash, with the balance owed to be paid in full within 30 days following opening of bids.

Unsuccessful bidders' checks will be returned the day of sale. Bidders must bring a valid driver's license for identification purposes; checks will not be released without proof of identity.

The high bidder's check will be held as a deposit and deducted from the total bid at the time of final settlement. 
