The North Dakota State Department of Transportation will be holding its LIVE State Fleet Services auctions, **however there will be NO onsite bidding** during the fall of 2020. This change was made due to COVID mitigation efforts and social distancing requirements.

The State Fleet Vehicle Auctions will be live streamed and take place **exclusively online** for the remainder of the year through our simulcast online bidding process located at [www.BidOrr.com](http://www.BidOrr.com). Buyers must place their bids through the internet using a computer, smartphone or tablet as there will be no on-site in person option to purchase State Fleet Vehicles at this time.

Items for sale will be available for viewing online at [www.orrauctioneers.com](http://www.orrauctioneers.com) or in person from **8 am to 3:30 pm, MONDAY AND TUESDAY ONLY**, the week of the sale.

**Purchase orders** from Government Political Subdivisions will be accepted, however, payment on purchase orders **must** be received within ten (10) days of the date of the auction.

Buyer accepts full responsibility for all purchases made and holds the auction company, clerks, and owners free of any liabilities in the event of theft or disappearance of any items purchased. No items to be removed from the premises without full settlement. Purchaser must assume all responsibility, all cost of title transfer and required registration fees.
- **REMOVAL OF VEHICLES** – All online purchases **must** be removed from the premises within seven (7) business days.
