

 material, changing and reshaping the existing channel, and modifying the drainage over land lying and being in

The purpose of this easement is to grant to the state of North Dakota, for the use and benefit of NDDOT, the right to remove material for construction purposes, deposit waste from said construction excavation, and perform such maintenance as may be necessary to construct and maintain drainage over and across the above-described lands.

Further, it is a specific condition of this easement that the Grantor(s) shall retain ownership and use of the above-described property after construction has been completed and grants to the state of North Dakota, for the use and benefit of NDDOT, the right of entry during the period of construction and in perpetuity thereafter for the necessary maintenance of the facility to be constructed.

The Grantor(s) further agrees to release the state of North Dakota, its successors and assigns from all claims for any and all damages resulting to the lands through and across which the parcel of land herein described is located by reason of such construction and maintenance and the removal of materials from the premises hereby covered and from uses incident thereto.
