

NORTH DAKOTA FLEET VEHICLE AUCTION TERMS & CONDITIONS

The North Dakota State Department of Transportation will be holding its Live Streamed Online State Fleet Services auctions. **There will be NO onsite bidding.** This change was made due to COVID mitigation efforts and social distancing requirements.

The State Fleet Vehicle Auctions will be live streamed and take place **exclusively online** through our simulcast online bidding process located at www.BidOrr.com. Buyers must place their bids through the internet using a computer, smartphone or tablet as there will be no on-site in person option to purchase State Fleet Vehicles at this time.

- **PAYMENT PROCESS** – All purchases **should** be paid in full day of the sale. Auctioneer will be onsite until 5 pm the day of the sale and from 8 am to 5 pm the day after the sale to accept payment. Auctioneer accepts checks, cash, and wire transfer. Please contact Orr Auctioneer for other payment options. They do not accept credit cards.

Purchase orders from Government Political Subdivisions will be accepted, however, payment on purchase orders **must** be received within ten (10) days of the date of the auction.
