Used Dealer License:

Used Motor Vehicles, Trailers (with the exception of Travel Trailers), Motorcycles, UTVs, ATVs, Mopeds, Unconventional Vehicles, Snowmobiles, and Low Speed Vehicles.

Motor-Powered Recreational:

Off-Highway Vehicles (UTVs, ATVs, Mopeds, Dirt Bikes, Snowmobiles), Unconventional Vehicles, Motorcycles, and Low Speed Vehicles

Trailer Dealer License:

All Trailers (with the exception of Travel Trailers), and Low Speed Vehicles

Motor Home License:

Motor Homes, Mobile Homes, Manufactured Homes, and Travel Trailers (includes Horse Trailers with living quarters), and Low Speed Vehicles.

Low Speed:

Low Speed Vehicle
