Any Lifetime CDL Disqualification you are applying to have reinstated must have been in effect for a minimum of 10 years.

Any Lifetime CDL Disqualification that is based upon a conviction for using a vehicle in the commission of a felony involving manufacturing, distributing, or dispensing a controlled substance while operating a commercial motor vehicle or a non-commercial motor vehicle or upon a conviction of using a commercial motor vehicle in the commission of a felony involving an act or practice of severe forms of trafficking is not eligible for reinstatement of a Lifetime CDL Disqualification.

#### Reinstatement Requirements (upon approval):

Complete the North Dakota Safety Council's "Attitudinal Dynamics of Driving" course. Visit <a href="https://www.ndsc.org">www.ndsc.org</a> and search Attitudinal Dynamics of Driving.

Complete the North Dakota Safety Council's "Professional Truck Driver" course.

Visit www.ndsc.org and search Professional Truck Driver.

Successfully pass all applicable knowledge tests to obtain a North Dakota Commercial Learner's Permit (CLP). Fees are \$5 for the CDL road test.

Participate in the Twenty-Four Seven Sobriety Program for three months from the date you pass your commercial road test if your disqualification involved an alcohol or drug violation. Please note, you will not be issued your CDL until the SFN 60363 Twenty-Four Seven Sobriety Program form has been submitted by your local law enforcement agency and approved by our office. This form can be found at <a href="dott.nd.gov">dott.nd.gov</a> by searching SFN 60363. If you violate the Twenty-Four Seven Sobriety Program, you will not be eligible for reinstatement and will be subject to a permanent Lifetime CDL Disqualification.

If you are convicted of any major offenses listed in 49 CFR 383.51 including drugs or alcohol, leaving the scene, or felonies involving the use of any motor vehicle at any time after your Lifetime CDL Disqualification has been reinstated, you will be subject to a permanent Lifetime CDL Disqualification.
