# Understanding the Race-Conscious and Race-Neutral Provisions in the USDOT's DBE Program

The U.S. Department of Transportation's (USDOT) Disadvantaged Business Enterprise (DBE) program aims to level the playing field in transportation contracting by increasing



opportunities for businesses owned by racial minorities, women, and other disadvantaged groups. This is achieved through a combination of race-conscious and race-neutral provisions.

Within a specific state's DBE program, there is a percentage of contract dollars that must be awarded annually to DBE-certified businesses. Each state defines this percentage goal differently. This goal is then further broken down into a "race-neutral" percentage goal and a "race-conscious" percentage goal.

# **Understanding the Difference:**

Race-conscious provisions: These directly consider race, ethnicity, and gender in awarding contracts. The most common example is contract goals, which set a specific percentage of a project's total value that must be subcontracted to DBEs.

## Provision Highlights:

 Contract Goals: Setting specific targets for the percentage of DBE participation in DOT-funded contracts. This ensures that a certain proportion of the work goes to qualified DBE firms.



- Outreach and Mentoring: Actively seeking out and supporting DBE firms through programs like mentorship, technical assistance, and networking events.
- Commercially Useful Function (CUF) requirements: Ensuring that DBEs perform a meaningful part of the work on a contract, not just acting as a passive subcontractor.

**Race-neutral provisions:** These focus on creating a fair and equitable environment for all businesses, regardless of their owners' race or gender. Examples include outreach and technical assistance programs that help all small businesses compete for contracts, as well as mentoring and partnership initiatives that connect DBEs with prime contractors.

The USDOT program emphasizes the use of race-neutral measures to the maximum feasible extent. This means that outreach, training, and other support programs should be the first line of attack in increasing DBE participation. Contract goals are then used as a backup measure when race-neutral efforts fall short.

# Provision Highlights:

- Open Competition: Ensuring that all qualified businesses, regardless of their ownership status, have a fair chance to compete for contracts.
- Transparency and Accountability: Requiring clear reporting and monitoring of DBE participation to ensure program effectiveness and prevent discrimination.
- Capacity Building: Providing training and resources to help all businesses, including DBEs, grow and succeed.
- Mentorship and training programs: Open to all businesses, regardless of DBE status, fostering a more skilled and competitive workforce.
- Streamlined procurement processes: Reducing administrative burdens for all businesses, making it easier for everyone to participate in bidding processes.



## **Compare and Contrast:**

- Focus on Race: Race-conscious provisions explicitly consider race or ethnicity in program design, while race-neutral provisions aim to assist disadvantaged businesses without directly considering race.
- Targeted vs. Universal: Race-conscious provisions target specific minority groups for assistance, while
  race-neutral provisions offer aid to any qualifying disadvantaged business, regardless of the owner's
  race.
- Remedial vs. Equal Opportunity: Race-conscious provisions aim to address historical disparities, while race-neutral provisions prioritize equal opportunities based on qualifications rather than historical context.
- Specific vs. General Support: Race-conscious provisions often provide tailored support services, while race-neutral provisions offer more generalized assistance to all qualifying businesses.

# **Finding the Right Balance**

The effectiveness of the DBE program depends on finding the right balance between these two approaches. Using too many race-conscious measures can raise concerns about reverse discrimination, while relying solely on race-neutral provisions risks perpetuating existing inequalities.

The USDOT carefully considers several factors when determining this balance, including:



- The availability of qualified DBE firms in a specific region.
- The historical discrimination faced by different disadvantaged groups in the transportation industry.
- The overall goals of promoting a diverse and competitive contracting environment.

It is important to remember that the DBE program is not about giving handouts. The goal is to create a level playing field where DBEs can compete fairly and win contracts based on their merit. The program provides the tools and resources to help DBEs succeed, but it is ultimately up to each business to seize the opportunity.

The DBE program has been instrumental in increasing opportunities for disadvantaged businesses in the transportation industry. However, it is not without its challenges. Critics argue that contract goals can be unfair to non-DBE businesses, while supporters maintain they are necessary to overcome historical discrimination.

The DBE program is not a quick fix, but rather a long-term effort to address systemic inequities in the transportation industry. The USDOT is constantly working to improve the DBE program and ensure it is fair, effective, and beneficial to all stakeholders. As we move forward, it is important to have a nuanced understanding of both race/gender-conscious and race/genderneutral provisions, and to recognize the role they play in creating a more equitable transportation landscape.



### Remember:

- The DBE program is complex and nuanced.
- It is important to have a respectful and openminded discussion about the program's merits and challenges.
- The ultimate goal is to create a transportation industry where all businesses have the opportunity to compete and succeed.



# Unique Entity ID (UEI)

The Unique Entity ID is a 12-character alphanumeric ID assigned to an entity by SAM.gov. Previously, companies utilized a Data Universal Numbering System (DUNS) number, part as part of the transition, the DUNS number was removed from the site.

New entities can get their UEI at SAM.gov when completing registration, where an existed registered entity can find their UEI by following the steps outlined <u>here</u>.

## Validation Process

After completing the required forms and submitting your business information, your registration on SAM.gov will undergo a validation process. This step is crucial to verify the accuracy and authenticity of the provided information. During validation, the government may perform checks to ensure your business exists and is in good standing. Delays can occur if there are discrepancies or inaccuracies in your registration information, underscoring the importance of providing correct details from the outset.

It's essential to note that the registration and validation process on SAM.gov can take several weeks to complete. Therefore, it's advisable to start this process well in advance if you anticipate pursuing government contracts. Additionally, maintaining up-to-date information on SAM.gov is an ongoing responsibility to ensure your eligibility for contract opportunities and compliance with government regulations.

### **NAICS** Codes


The North American Industry Classification System (NAICS) codes are a standardized system used to classify businesses based on their primary economic activities. Selecting the right NAICS codes for your business is crucial for effectively identifying contract opportunities that align with your capabilities. Here's how to approach this:
