FEBRUARY 7, 2025 BID OPENING UPDATE

- All projects awarded & all DBE Goals Met
 - No RGN DBE Participation
 - Overall DBE Participation 3.82% adjusted for FAS
 - Total to DBEs: \$1,392,829
 - \$175,441 to DBE Subcontractors – 12.60%
 - \$498,314 to DBE Trucking – 35.78%
 - \$329,505 to DBE Distributors – 23.66%
 - \$297,659 to DBE Suppliers – 21.37%
 - \$91,909 to DBE Manufacturers – 6.60%

 - 1 Project NOT Federally Funded – No DBE requirements apply
