JANUARY 10, 2025 NDDOT BID OPENINGS

DECEMBER 13 & 20, 2024 BID OPENING UPDATE

- December 13th Bid Opening - All DBE Goals Met

- 23706 & 23972 pending award as of 1/6

- Overall DBE Participation 5.60% adjusted for FAS

- \$567,693 to DBE Subcontractors – 72.79%
- \$196,338 to DBE Suppliers – 25.17%
- \$11,315 to DBE Trucking – 1.45%
- \$4,548.72 to DBE Distributors – 0.58%

- December 20th Bid Opening – All DBE Goals Met

- Both projects pending award (scheduled for 1/6)

- Overall DBE Participation 8.16% adjusted for FAS

- \$2,248,700 to DBE Subcontractors – 51.45%
- \$2,117,031 to DBE Distributors – 48.45%
- \$4,211 to DBE Trucking – 0.10%

JANUARY 10, 2025 BID OPENING

- 7 Federal Aid Projects
 - 24481 is not Federally Funded – No DBE requirements apply
 - 3 Projects with DBE Goals

- Form B/Bidders List Requirement – Primes please only submit 1 copy (either in BidX or via email to subquotes@nd.gov)
- 1:1 DBE Trucking Ratio still under review
- Comprehensive DBE Trucking Roster currently being created
 - DBE trucking firms must provide documents regarding ownership (must own at least 1 truck) and **long-term** lease from a **reputable dealer** for any trucks
- DBEs gone for winter & no B2GNow (CCS) access when outside of US/Canada
 - DBE Certification Renewals (you can complete them early)
 - DBEs added to Utilization Plans & Payment Confirmations
- Track of micro-trainings coming for DBEs early spring (virtual)
