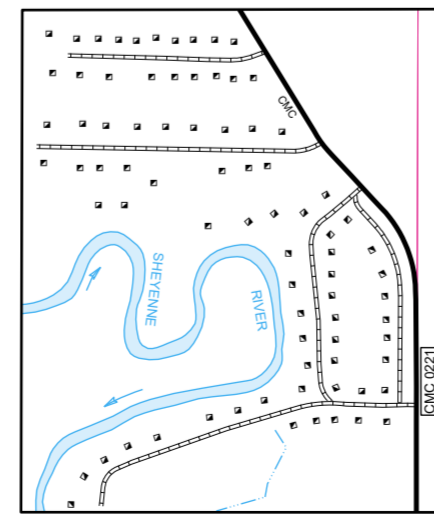
STATE OF NORTH DAKOTA

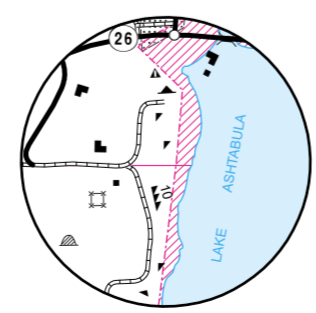

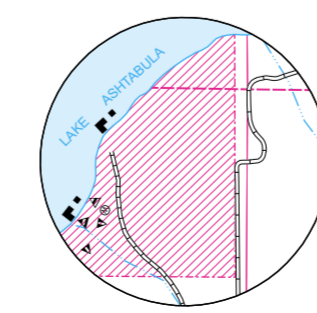
